# **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to sugarandspicejefferson.com, and Sugar n Spice Cafe & Catering and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Sugar n Spice Cafe & Catering include sugarandspicejefferson.com and Sugar N Spice. # **Collection of your Personal Information**

In order to better provide you with products and services offered, Sugar N Spice may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

Sugar N Spice may also collect anonymous demographic information, which is not unique to you, such as your:

- Age
- Gender

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. #### **Use of your Personal Information**

# **Sharing Information with Third Parties**

Sugar N Spice does not sell, rent or lease its customer lists to third parties.

Sugar N Spice may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries.
